

DESCRIPTIONS OF SUPERVISOR DISTRICTS IN CARROLL COUNTY, IOWA

SUPERVISOR DISTRICT ONE (4256)

All that part of the City of Carroll located, for the most part, south of the following described lines: Beginning at the west corporate line, located approximately two thousand five hundred thirty-nine feet west of the centerline of Burgess Avenue, at the Centerline of U.S. Highway 30 and following the centerline of all described streets, thence east and southeasterly to the centerline of West 10th Street, thence easterly to the centerline of Quint Avenue; thence northerly to the centerline of West 14th Street; thence easterly to the centerline of Simon Avenue; thence southerly to the centerline of West 10th Street; thence easterly to the centerline of East 10th Street, continuing easterly to the centerline of North Clark Street; thence northerly to the centerline of East 11th Street; thence easterly to the centerline of Forest Street; thence southerly to the centerline of Woodland Drive; thence easterly to the centerline of Bella Vista Drive; thence southerly to the centerline of U.S. Highway 30; thence easterly to the east corporate line.

SUPERVISOR DISTRICT TWO (4308)

Wheatland Township; Kniest Township; the City of Breda; Sheridan Township; the City of Lidderdale; Jasper Township; the City of Lanesboro; the North one half of Glidden Township; the North four miles of Grant Township; the North four miles of Maple River Township; and that part of the City of Carroll lying, for the most part, north and west of the following described lines: Beginning at the northern and western corporate limits, located approximately one hundred feet north of the intersection of North West Street and Fairway Heights; thence southerly along the center of all described streets to the centerline of West 13th Street; thence westerly to the centerline of Simon Avenue; thence northerly to the centerline of West 14th Street; thence westerly to the centerline of Quint Avenue; thence southerly to the centerline of West 10th Street; thence westerly to the centerline of U.S. Highway 30; thence northwesterly and westerly to the corporate line, located approximately two thousand five hundred thirty-nine feet west of the centerline of Burgess Avenue.

SUPERVISOR DISTRICT THREE (4292)

Arcadia Township; the City of Arcadia; Washington Township; Ewoldt Township; the City of Manning; Eden Township; the City of Templeton; Roselle Township; the City of Halbur; and the south two miles of Maple River Township.

SUPERVISOR DISTRICT FOUR (4276)

The South one half of Glidden Township; the City of Glidden; the City of Ralston; Richland Township; Union Township; the City of Coon Rapids; Newton Township; the City of Dedham; Pleasant Valley Township; the City of Willey; and the south two miles of Grant Township.

SUPERVISOR DISTRICT FIVE (4289)

All that part of the City of Carroll located, for the most part, north and east of the following described lines: Beginning at the northern corporate limits, located approximately eleven hundred seventy-two feet north of the intersection of North West Street and Thirtieth Street; thence southerly along the center of corporate limits and all described streets to the centerline of West 13th Street; thence westerly to the centerline of Simon Avenue; thence southerly to the centerline of West 10th Street; thence easterly to the centerline of East 10th Street, continuing easterly to the centerline of North Clark Street; thence northerly to the centerline of East 11th Street; thence easterly to the centerline of Forest Street; thence southerly to the centerline of Woodland Drive; thence easterly to the centerline of Bella Vista Drive; thence southerly to the centerline of U.S. Highway 30; thence easterly to the east corporate line.
